PALOMAR AIRPORT UPDATE

Leaders of Carlsbad's

Citizens for a Friendly Airport
presented their case against
the proposed expansion of
the McClellan-Palomar Airport
at South Vista Communities'
January 25 meeting.



Hope Nelson, representing the group, provided the following update:

They are committed to ensuring nothing happens until the full story of what the plans are for Palomar is disclosed, including a fair discussion with all stakeholders, including residents.

Current position: NO EXPANSION.

- The 800-ft. expansion would bring the runway to 5,697 ft, the same size as John Wayne airport (5.701 ft)
- We do not need more air traffic over our communities 24/7.
- We do not want the increased traffic; Palomar Airport Rd can not handle it adequately.
- * We are concerned for property values and erosion of the biggest tax generator for our cities (property taxes).

They are currently focused on the proposed McClellan-Palomar Airport master plan and PEIR (program environmental impact report). Substantive comments were received by the County on the PEIR by the March 19 deadline.

The City of Carlsbad hired outside legal counsel (Kaplan, Kirsch & Rockwell, in Denver), who prepared Carlsbad's excellent comment letter on the PEIR: http://www.carlsbadca.gov/civicax/filebank/blobdload.aspx?BlobID=35531

The document points out numerous inconsistencies in the PEIR, including lack of information related to commercial service and impacts of noise, air quality, geological and greenhouse gas emissions.

Carlsbad City Council has not yet taken a position with the County on the airport. Next discussion: Carlsbad City Council meeting on Tuesday, April 10, 6 p.m., 1200 Carlsbad Village Drive.

OUR WATER AND WEATHER

Dry conditions and dramatic swings in annual precipitation in California are nothing new. Thanks to a decades-long water supply diversification plan, including the addition of desalinated seawater, and a long-standing commitment to water use effi-



ciency, the San Diego County Water Authority, Vista Irrigation District's (VID) water wholesaler, has indicated that San Diego region is well-prepared to meet water demands in 2018. That being said, as dry conditions persist, it is important that the region continue to use water efficiently.

Currently, VID is at Level 1 of its Water Supply Response Program. Level 1 mandatory water use efficiency practices include eliminating irrigation run-off, not irrigating landscapes within 48 hours of measurable rainfall, not using water to wash down paved surfaces, and repairing leaks in a timely manner. VID appreciates its customers' water conservation efforts and encourages them to continue to follow the water use efficiency practices outlined above.

To help its customers save water, VID offers incentives for water conserving devices through the SoCal Water\$mart rebate program. Customers can visit VID's website at www.vidwater.org for more information on water conservation.
