
### YEAR-END UPDATE ON PROJECTS

[We thank John Conley, Vista's Director of *Community Development, for an update on several* pending projects in Vista.]

- The Marriott Courtyard project on Shadowridge Dr. has been approved by PC, but the developer said they are waiting for 6-12 months to pull construction permits due to the slowdown in hotel occupancies from COVID.
- The Hilton Garden Inn project that was approved next to Hyatt Place on So. Melrose is dead according to the property owner, the developer pulled out of the deal shortly after the pandemic started. There has been no news on that project since then - the property owner is searching for a hotel developer to build the approved project.
- Still nothing on a homeless shelter in the Burlington site, but the owner (The Charles Company) has approached the City about the possibility of changing the zoning to allow multi-family residential there after Burlington moves out. If they chose to move forward, we will schedule for discussion (preliminary review of a zone change) at a regular City Council meeting to review the request, so I will keep you posted if that is scheduled early next year.
- Nothing with Jerry Suppa's property either (SE corner of Melrose/Matagual)... as far as I know, he is still contemplating a mixed use project with a drive-through coffee shop at the corner and housing behind, but hasn't contacted us in over a year.



## GOOD SHEPHERD CEMETERY

A Major Use Permit application for the proposed cemetery was submitted to Planning & Development Services in May 2020. As part of that submittal, a notice was mailed out to property owners within 300 feet of the project site informing them of the proposed project.

The project site is not located in an area represented by one of the County's formal community planning or sponsor groups. Because of this, staff recommended that the applicant reach out to the neighboring community about the project. We provided an updated mailing list and the applicant's team sent a letter to surrounding residents in July. They then conducted several online meetings for neighbors to discuss the project.

County staff is reviewing the proposed project. This includes providing the applicant with detailed comments, including revisions to project plans and accompanying environmental studies. We anticipate that a 30-day public review and comment period will begin in early or mid-2021. We will send out another notice notifying surrounding property owners of this public review period. After public review, staff will examine each comment and prepare written responses. Comments may result in revisions. Staff will then schedule the proposed project for a public hearing by the Planning Commission. Another notice will be sent to property owners informing them of the public hearing and how to comment and participate in the hearing. The public will be
