NEW: SMALL LOT RESIDENTIAL

ZONING

Following up on the article in January's newsletter about the new state zoning laws, Vista's Community Development staff are looking at a new small lot residential zoning category.

Some Vista neighborhoods already have many of the characteristics of small lot zoning — Calypso, Heritage, Legends, for example — but these houses are part of condominium associations.

The new zoning describes minimum lot sizes of 3600 sq. ft. along with side yard setbacks of five feet and rear yard setbacks of ten feet coupled with open space requirements.

When the small lot zoning was presented for discussion at the February 22 City Council meeting, Mayor Judy Ritter recommended including adequate storage requirements for each house and Deputy Mayor John Franklin recommended maintenance standards for the front yards. Small lot zoning will be presented to the Planning Commission in April and to City Council again in May.

UPDATE ON PALOMAR AIRPORT MASTER PLAN



C4FA recently met with Supervisor Lawson-Remer and staff to review the Board of Supervisor's Dec 8, 2021 vote on the most recent Palomar Airport Master Plan Update. We were able to clarify that :

- Palomar Airport will remain a B-II Airport in the new Master Plan Update
- EMAS (Engineered Material Regressing System – think runaway truck stops) will be added to one end of the existing runway
- The runway will be extended on the opposite end of the existing runway by 200 feet (+/- 10% - so let's be real - it's a 220 foot extension).
- Airport Operations may come back to the Board of Supervisors at some date in the future with D-III design standards

We have a follow-up meeting with Supervisor Lawson-Remer's office to gain a further understanding of:

- What exactly this vote means
- The expected timeframe of the runway extension and EMAS installation
- The process that will be followed for each project

• An explanation of the funding sources.

C4FA believes the 200-foot runway extension is unnecessary. We will be watching very carefully. For those who are interested, you may read the Dec 8, 2021 Board of Supervisors Minute Order for the Palomar Airport Master Plan Update here.

PALOMAR AIRPORT (Cont.)

Now that the County legal issues are settled, we are developing a strategic course of action to pressure our elected officials at the local, state, and federal levels regarding noise and pollution issues.

Work with the State and Federal Government will be challenging and slow. We have candidates currently running for State and Federal office who can help. We will not be alone, considering the environmental issues associated with airports in general across the nation.
