- Current flights already ignore the restrictive flight paths.

Great News! C4FA is pleased to announced that the **City of Carlsbad Planning Commission approved 3 Resolutions to move Carlsbad's new General Plan and Zoning Amendments forward to the Carlsbad City Council for consideration** by a vote of 6-1. These General Plan and Zoning Amendments will help ensure that the City of Carlsbad retains **LOCAL CONTROL** of any expansion plans at Palomar Airport, as granted by the Annexation Agreement and upheld by the Courts.

The matter is expected to be on the Carlsbad City Council Agenda in November. Stay tuned. We'll keep you posted.
